Addendum

regarding the professional activity of the students from the bachelor and master's degrees at the



Western University of Timisoara and the UVT Methodology regarding the organization and conduct of the admission process for the university study programs at the bachelor's degree level.

- **2.2**. For the academic year 2022-2023, given his/her status of recontracting studies, the student has to pay the fee of enrolment for recontracting studies in the amount of 300 lei at the time of submitting the application for the state of recontracting of studies, and where applicable:
- the examination fee in the amount of 100 lei/examination sitting paid whithin a maximum of 5 working days since the beginning of the academic year, for the subjects attended in a previous academic year and for which all the obligations provided in the subject syllabus have been fulfilled, also mentioned as such in *The Subjects Agreement*;
- the re-contracting the subject fee, calculated according to the formula tuition fee/60 x the number of credits allotted to that subject paid whithin a maximum of 5 working days since the beginning of the academic year for those subjects for which the student has not fulfilled all his/her obligations as present in the subject syllabus in a previous academic year, also mentioned as such in *The Subjects Agreement*.
- **2.3.** Non-payment of the corresponding fee will lead to the impossibility of sitting the examination.
- **2.4.** The subjects contracted, their status (re-sit/re-contract) and the number of credits allotted are to be found in the provisions of *The Subjects Agreement*.

Article 3. Final dispositions

- **3.1.** The Dean of the Faculty, by empowerment, drawing on the WUT Rector's Decision no. _____, signs the present addendum.
- **3.2.** Failure to fulfil the obligations incurred from the present addendum is subject to the sanctions provided for by the University's regulations, as suggested by the faculty's council, according to the effective laws.
 - **3.3.** The present addendum comes into effect starting with the date it is signed.
- **3.4.** The present addendum has been executed in 2 original copies, one for each party, and represents the will of the contracting parties. One copy of the addendum is to be filed together with the student's personal documents, at the faculty secretariat, while the other is to be delivered to the student.
